It also establishes various eligibility requirements for firefighters to receive benefits under the program. The bill does not specify (1) what type of benefits the program or policy must provide (e.g., medical or wage replacement benefits), (2) the benefit rate (100% reimbursement or some lesser amount), (3) the benefit's duration, or (4) which state agency must administer the program.</p> <p>The bill also expands a reporting requirement for fire chiefs and local fire marshals to include certain information about the firefighters present at each fire, explosion, or other fire emergency and their exposure to heat, radiation, and carcinogens.)</p> <p>REF.
