Please note that the language available for the "PTSD Bill" (S.B. 164) is the latest available at the printing of the update. Chief Rick Hart of the UPFFA has scheduled a meeting of the Joint Council of Connecticut Fire Service Organizations on Wednesday of this coming week to discuss language changes for the bill that still need to be made. I will post developments here.

I have received feedback this week that there is growing concern about **H.B. 5658** ("The Red & Blue Lights Bill") and I plan to bring up the matter at the next Joint Council meeting. At this time, CSFA has not taken a position either for or against the proposed bill, however, that may change.

There is also concern that **S.B. 66** ("The Stretcher Van Bill") is moving forward and would potentially create dangerous transport conditions for stretcher-bound patients. I have asked for a meeting with one of the bill's co-sponsors next week. I will report any developments here in this weekly update.

Additionally, it appears that the "Fireworks Bill" (S.B. 664) is essentially dead and did not make it out of committee.

Also, legislators changed the language in Section 4 of the "Mobile Retail Gasoline Re-Fueling Bill" (**H.B. 7299**) to reflect the current fire code, however, there is no avenue of enforcement for those who might create violations.
